

DinoLab Privacy Policy

1. General

DinoLab AB, company registration no. 559527-0751 (“DinoLab”, “we”, “our”, or “us”), is committed to protecting your personal data and safeguarding your privacy. We implement appropriate technical and organizational measures to ensure your data is handled securely and in accordance with applicable data protection laws, including the General Data Protection Regulation (GDPR).

We protect your personal information and respect your rights to transparency, access, and control over your data. This Privacy Policy outlines how and why we collect and process your personal information, and your rights regarding such processing.

2. Data Controller

DinoLab is the data controller for all personal data collected via our website (www.dinohaddy.com) and in the context of our customer relationships and communication.

3. Definitions

3.1 Personal data refers to any information relating to an identified or identifiable individual, such as name, email address, IP address, or device information.

3.2 Processing includes any operation performed on personal data, such as collection, storage, use, modification, or deletion.

4. When We Collect Personal Data

6. Sharing of Personal Data

We may share your personal data with carefully selected third-party service providers who support us in delivering our services (e.g., hosting, payment processing, email delivery). These partners are contractually bound to comply with GDPR and handle your data securely.

We do not sell or rent your personal data, and we will not disclose it to third parties without your consent, except where required by law or court order.

7. Data Security

We take appropriate technical and organizational measures to secure your personal data against unauthorized access, disclosure, or misuse. While we strive for a high level of data protection, no method of transmission or storage is completely secure. We follow the EU General Data Protection Regulation (2016/679) and applicable Swedish law (2018:218).

8. Data Retention

Your personal data is retained only as long as necessary for the purposes for which it was collected, or as required by law. We retain data to fulfill contractual obligations and meet legal and regulatory requirements. For detailed retention periods, please refer to our Cookie Policy or contact us directly.

9. Your Rights

You have the right to:

- Request access to the personal data we hold about you
- Request correction of inaccurate data
- Request erasure of your data, unless we are legally required to retain it

- Withdraw your consent at any time
